Once a Tender is posted, two unique digitally encrypted keys are generated. These keys are e-mailed to the relevant authorised parties responsible for opening the Tender e-Box and documents.	
Tenders e-Box cannot be opened before specified Date and Time.	
Once Tender deadline has passed, vendors cannot submit to e-Box.	
Flexibility to accept proposals online as either Technical, Financial, Both Technical and Financial or Amendments.	
e-Dialogue: Receive Questions and Post Answers on Tenders Notices. All vendors are automatically updated via e-mail once an answer is posted.
